1. INTRODUCTION

The wide and varied use of industrial trucks and the need on occasions for them to be moved, under their own power, from location to location, sometimes travelling short distances on public roads, has focused members attention on the regulations covering such use and the circumstances under which trucks are allowed to make such journeys in the first place.

2. SCOPE

Trucks are allowed restricted travel on public roads. The Guidance Note provides information to enable the owner, the operator and the construction of the truck to comply with current regulations covering such use.

3. <u>REQUIREMENTS</u>

3.1 <u>Categories</u>

The Department for Transport (DFT) has indicated that is categories of works trucks, industrial tractors and agriculture vehicles are permitted to travel on public roads provided they are registered appropriately.

- 3.2 Classification
- 3.2.1 The classification of vehicles is determined by the Driver and Vehicle Licensing Agency (DVLA). Where difficulties of definition are encountered the matter should be referred to the DVLA Customer Enquiry Unit or to a Vehicle Registration Office. (re: bibliography).
- 3.2.2 The classification depends on the vehicle construction, its use on a public road and in certain circumstances its revenue weight.
- 3.2.3 The definition of Revenue Weight for Vehicle Excise Duty (VED) purposes is, for the vehicles under consideration, the manufacturer's design laden weight.
- 3.2.4 Trucks may travel laden as well as unladen on a public highway provided the overall maximum legal weight and the wheel/axle laden weights are within that permitted by the Construction and Use regulations.
- 3.3 General Requirements
- 3.3.1 Number plates must be displayed on industrial trucks used on public roads, including those exempt from VED. It is the responsibility of the vehicle keeper to ensure the registration marks are correctly displayed. Letters and figures must be vertical and plate(s) are required on the rear of the vehicle or alternatively on either side.
- 3.3.2 Vehicles are required to have rear end reflector markings if:
 - a) they have a maximum speed exceeding 25mph;

or

b) their maximum gross weight exceeds 7500kgs

and

c) they were first used on or after 1st April 1986

However, if the vehicle is not fitted with any front or rear position lamps, then no such reflector marking is required to be fitted between sunrise and sunset. Re: Road Vehicle & Lighting Regulation 4 (3) (RVLA). Note: Due regard should be taken when weather conditions cause poor visibility. Vehicles used between sunset and sunrise must be equipped with appropriate lighting.

- 3.3.3 The showing of an amber light from a warning beacon, to the rear of a vehicle when travelling on public roads, is permitted only on certain vehicles under specific circumstances viz:
 - a) those having a maximum speed not exceeding 25mph
 - b) those used for the purpose of or relating to road improvements and maintenance
 - c) those used for or relating to inspecting apparatus in or under a road.

A warning beacon shall only be used when it is necessary or desirable to warn persons of the presence of the vehicle.

- 3.3.4 Vehicles used on public roads must embody engines meeting the emission standard ECE R49. For engines meeting the EURO 4 standard, read reduced VED rate in 3.5.2b).
- 3.3.5 Red diesel (rebated fuel) is largely restricted to farmers use and must not be used on public roads unless specific tasks and operations have the express written permission from H M Customs and Excise.
- 3.3.6 The forward projection of a load on any vehicle should not exceed 2 meters.
- 3.3.7 Reversing a truck on a public road for a prolonged period, for whatever reason, is not defendable and no Authority is likely to sanction such usage. Loads must therefore be arranged to provide clear forward vision and reverse gears must not be utilised for any prolonged period.
- 3.3.8 Small amounts of extra fuel for a vehicle may be carried by a vehicle on public roads in a tank which forms part of or is permanently attached to the vehicle provided the extra fuel does not cause the vehicle to exceed its maximum allowable gross weight.

Fuels are classified as dangerous in transport and several regulations cover their use notably; The Carriage of Dangerous Goods and use of Transportable Pressure Receptacles – Regulations 1996; The Carriage of Dangerous Goods by Roads – Regulation 1996; and the Carriage of Dangerous Goods by Roads (Driver Training) – Regulations 1996.

Queries regarding the transport of fuel should be directed to the Department for Transport – Road Haulage Division.

- 3.3.9 If dangerous goods are carried as a truck load, the Carriage of Dangerous Goods by Road etc. regulations will apply including the display of appropriate warning symbols. However, these requirements need not be applied if operation is restricted to that outlined in 3.5.1b.
- 3.4 Specific Requirements for Work Trucks
- 3.4.1 Fork arms should be removed, folded back or fitted with marker plates when travelling unladen on public roads. Similar measures should be taken with load handling attachments. During the hours of darkness marker plates etc. must be suitably illuminated.
- 3.4.2 An MOT inspection for industrial (works) trucks is not currently required.
- 3.4.3 Limited use works trucks may tow trailers only if they remain within the definition of a limited use works truck (see para 3.5.1b). It follows that if a limited use works truck ceased to comply with these requirements it would be by definition not be a works truck and would fall to pay VED at whatever alternative class was appropriate.

In towing trailers on public roads, works trucks need to comply with all relevant Construction and Use regulation requirements.

- 3.4.4 Independent wheel braking systems, if fitted, must be linked.
- 3.4.5 Trucks capable of all wheel steering should be arranged for front wheel steer with rear wheels locked in the straight ahead position.
- 3.4.6 Four wheel drive, if selectable, should normally be disengaged.
- 3.4.7 Different locks, if fitted, should be disengaged.

3.5 Licensing and Insurance

3.5.1 Registration

- a. For a "used" vehicle a licence is obtained at first registration on form V55/5. Note: (for ease of completion see Appendix 1) For a "new" vehicle on form V55/4, by application to a local Driver and Vehicle Licensing Agency (DVLA) Office. Re-licensing is possible at any post office authorised to issue licences. A Statutory Off Road Notification (SORN) declaration must be made on form V890 for vehicles where the licence disc expired on or after 31st January 1998. There is no need to make a SORN declaration for a vehicle while a licence disc is in force unless a VED Tax rebate is required. In which case form V14 must be completed.
- b. A works truck qualifies within this special vehicle class of registration "Limited Use" if it is designed for private premises use and is used on public roads only for carrying goods
 - i) between private premises

or

ii) to other private premises in the immediate vicinity

or

iii) for carrying good between private premises and a vehicle on a road in the immediate vicinity

or

iv) in connection with road works at or in the immediate vicinity

Note: For engined trucks the immediate vicinity is currently considered by the courts to be a maximum of 1.5km.

- c. An industrial tractor or truck may be registered as an 'agricultural machine' provided it is designed and constructed primarily for use otherwise than on roads, and incapable by reason of it's construction of exceeding a speed limit of 25mph, on the level under it's own power.
- d. The DVLA have confirmed that there is no requirement to register pedestrian controlled equipment for use on the road; additionally the RVLR 1989 clause 9 states these vehicles are exempt for all lighting requirements as long as they are used within the daylight hours.

3.5.2 Vehicle Excise Duty (VED)

- a) Trucks not used on public roads do not need to be licensed.
- b) The current rates of Vehicle Excise Duties (2006/7), as published by the Department for Transport on form V149 are:-

Note: (Always check the current V149 before making an application)

i) Works trucks, up to 3.5 tonnes (see paragraph 3.2.3) propelled by internal combustion engines – i.e.

Light Goods Vehicles:-

Part 1 TC39 Registered on or after 1st March 2001; £170 per annum; or (£93.55 for 6 months)

Euro 4

Part 1 TC36 Registered on or after 1st March 2003; £110.00 per annum; or (£60.50 for 6 months)

ii) Works trucks, over 3.5 tonnes, propelled by internal combustion engines – i.e. Special Vehicles:- Part IV TC14 £165.00 per annum; or (£90.75 for 6 months)

iii) Vehicle Excise Duty Exemptions for tax classes, "Limited use Vehicles & Agricultural machines:

Vehicles which comply with 3.5.1; b) & c) are exempt

Electric Works Trucks powered by traction battery are exempt. Note; (Diesel electric trucks do not qualify as electric works trucks).

- iv) Exemptions from paying Vehicle Tax:The law requires that vehicle tax should be paid for any vehicle used or kept on a public road in the UK. Certain vehicles are exempt from paying vehicle tax, however, these vehicles still require to be taxed annually and are issued with a "nil" or free tax disc. Applications for vehicles first being taxed as "exempt" must be made at a (DVLA) local office. The application must be made on a V10 form, available for download from the forms link, see bibliography also DVLA local offices and Post Office branches. Supporting documentation must be provided as listed in the link. Future Tax/SORN renewals can take place using the Tax renewal reminder form that will usually be sent by the DVLA.
- c) 'Trade Plates' (manufacturer's plates) may be used on trucks on public roads provided the user qualifies for trade plates use. The current annual cost is £165.00 or £90.75 for 6 months.
- d) Agricultural vehicles used on public roads for less than 1.5km per journey between lands occupied by the same person are eligible to be licensed in the 'agricultural machine tax class' which automatically confers exemption from VED.

3.5.3 Driving Licence

- a. No (road going) driving licence is needed to operate trucks not driven on public roads, but the requirements of the Health and Safety at Work Act 1974 apply.
- b. The minimum driving ages applicable on public roads are:
 - i) Agriculture vehicles 17 years
 - ii) Industrial trucks of less than 3.5 tonnes (MAM) 17 years (Note: "MAM" relates to the "Maximum Authorised Mass" which is the truck's total weight plus the maximum load it can carry).
 - iii) Industrial trucks over 3.5 tonnes and under 7.5 tonnes (MAM)- 18 years
 - iv) Industrial trucks over 7.5 tonnes (MAM)- 21 years
- c. The following road driving licence categories apply to exempt large goods vehicles:
 - i) Works trucks and industrial tractors category B. (car) Licence
 - ii) Agricultural vehicles either a Category B (or Group A if the licence was issued before 1st June 1990 or a Category F Licence)

i)

- A Category B (or Group A if issued before 1st June 1990) licence automatically gives entitlement to Category F.
- A higher large goods vehicle licence (LGV) is not required to drive works trucks ii) of any capacity on public roads.
- Industrial tractors must not exceed an unladen weight of 7370kgs and a design iii) speed of 20 mph.
- d. Provisional driving licence holders may drive trucks on public roads provided:-
 - The driving licence held by the driver covers the vehicle category driven.
 - ii) 'L' plates are displayed on the front and rear of the vehicle.
 - If the vehicle is constructed for more than one person a qualified driver who is iii) at least 21 years old and holds a full valid British, Northern Ireland or EU Community licence in the appropriate category and has done so for 3 years or more, must accompany the provisional holder.
 - The driver (operator) must be properly trained in accordance with the Health & iv) Safety at Work Act 1974, etc.
- Drivers of vehicles which may be driven on a Category B (car) licence are no subject e. to higher medical standards (except on renewal of C1 and D1 entitlement at age 70 and over when a medical examination report D4 must be signed by a doctor).
- f. A full driving licence may be obtained by:
 - i) Applying to the DVLA for a provisional licence form D1 obtainable at post
 - Applying for and passing a driving test and theory test in an appropriate vehicle ii) (driving tests can be booked by completing form DL26 obtainable at driving test centres).

Note It is sometimes possible for 'on site home tests' to be arranged.

3.5.4 <u>Insurance</u>

The minimum insurance required is third party liability at all times for any road use however small.

Note: It is recognised that "over the pavement" unloading and loading is often practised without registration of trucks and without insurance. Such condonable "Blind Eye" practices carry with them the risk of prosecution and should be avoided at any time.
